# OPEN ENROLLMENT FOR EMPLOYEES REPRESENTED BY UTD, AFSCME, DCSMEC, MEP AND CEP ONLY WILL BE HELD February 27 THROUGH March 09, 2012 For benefits effective April 01, 2012

THIS IS A <u>MANDATORY</u> ENROLLMENT. IF YOU DO NOT ENROLL DURING THIS ENROLLMENT PERIOD, YOUR CURRENT BENEFITS AND THOSE OF YOUR DEPENDENTS WILL TERMINATE ON MARCH 31, 2012. YOU MUST LOG ON TO <u>WWW.DADESCHOOLS.NET</u> AND COMPLETE YOUR ENROLLMENT. If you have experienced a change in salary band, your employee cost will be automatically adjusted. Changes made during this enrollment will become effective April 01, 2012 and any changes to your deductions will be reflected in the April 6, 2012 payroll.

The School Board continues to provide Miami-Dade School Board employees with a healthcare option at no cost for employee only coverage through the CIGNA Open Access Plus (OAP) 20 plan. CIGNA (OAP) 10 does have an employee cost share determined by the employee's annual salary band. The School Board will continue to subsidize the cost of dependent premiums between 70% and 90%. However, employees will experience an increase in dependent

healthcare costs effective April 01, 2012.

There have been plan design changes to the medical benefits for April 1, 2012 so it is imperative that you review the benefits before you make your benefit selection. Rates for all the benefits can be found on the last few pages of the 2012 Benefits Guide located at www.dadeschools.net then click on Employee Benefits.
